Cost Share Information: If pasture fertility is requested it may not exceed lab recommended nutrient requirements. Soil sample analysis must have been collected 1 sample per each 5 acres within the past 3 years or additional samples can be collected as part of this project. Note soil samples will be paid for directly by Root-Pike WIN to Rock River Labs.

Number of Soil Samples Requested: $\frac{X \text{ Acres}}{5} = [X]$ soil samples needed.

Planned Year of Installation is 2024. Each practice must be installed, and all costs associated must be incurred by November 15th, 2024. To receive reimbursement, the following must be submitted within 15 days of practice completion to kristine@rootpikewin.org / 262-327-0167.

- 1) Copies of all receipts for cost share practices (seed, fertilizer, custom planting, and all materials for rotational grazing including fencing, waterlines, water jugs, etc.).
- 2) Photo documentation of the practice being implemented is required. Please email or text photos along with your name and the practice implemented. Farm visits may be required on a case-by-case basis.
- 3) A completed W-9
